Introduction to the Application Process for the Associate Degree Nursing Program

Vision Statement:

- x IRSC School of Nursing (SON) aspires to be a model of excellence by transforming students through nursing education

Purpose Statement:

The School of Nursing at IRSC is committed to meeting the educational needs of future and current professional and vocational nurses within an ever-changing healthcare system. Faculty facilitates student achievement utilizing various teaching modalities. In our effort to serve the global community and its diverse cultures, we commit to:

- x Develop excellence in nursing education and practice
- x Provide quality, student-centered learning to promote student success
- x Create multi-dimensional learning experiences

The Associate Degree Nursing Program (ADN) may be completed **five** semester with one semester of pre-requisites and four semesters of nursing courses. Applicants who are eligible for Advanced Placement/Bridgeway complete the program in four semesters with one semester of pre-requisites and three semesters of Nursing Courses. Attainment of the Associate Degree in Nursing includes 42 credits in nursing courses and 30 credits in general education courses.

The Associate Degree Nursing Program offers two tracks.

Track One: Regular admission tract. Students complete four semesters of nursing course along with required general education courses. The program length is a total of five semesters.

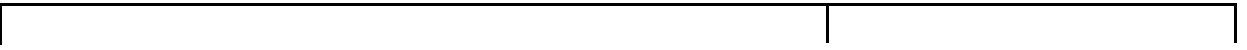
Track Two: Advanced Placement/Bridge Placement Option is for Licensed Practical Nurses, Registered Respiratory Therapists and Licensed Paramedics. The program length is a total of three semesters of nursing courses along with one semester of pre-requisites of general education courses for a four-semester program; as some students are eligible to test out of the first semester of nursing courses. Applicants should carefully review the application procedures outlined in the Application Booklet and online. Admissions to the Associate Degree Nursing program is on a selective admission basis. It is the applicant's responsibility to ensure that the application process is completed.

Note: If at any time during the application process you have a change in personal information (name change, address, phone number, or emails), submit the changes to Student Records and to the School of Nursing.

ACCEPTANCE INTO PROGRAM

The School of Nursing will notify applicants via email regarding the status of their application six to eight weeks after the application closes. An initial email will be sent to those who have been provisionally accepted or provided an alternate status. Alternate status expires at the beginning of the cohort semester. Acceptance into the program will be sent to their IRSC RiverMail account or personal email if RiverMail account is not yet active.

Final acceptance into the program is contingent upon satisfactory results from a

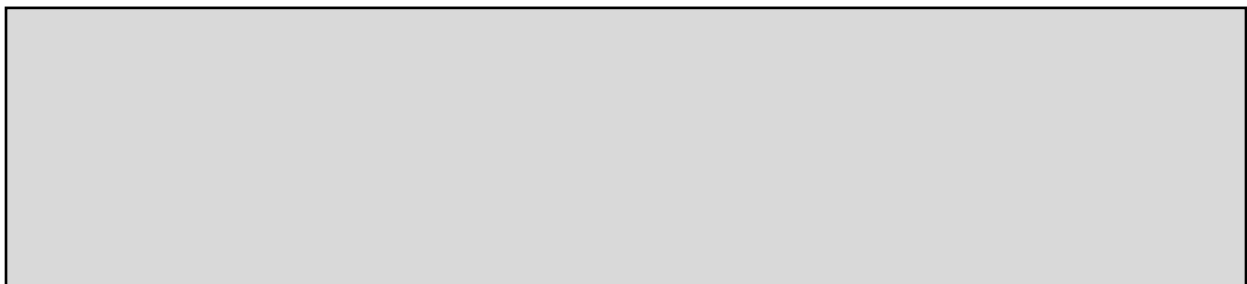
- x Physical examination with immunization,
- x Drug screen,
- x CPR certification and
- x Federal Bureau of Investigations National Background Check (FBI/NBC).
- x Attendance to mandatory orientation sessions (see website for dates.)

Additional information regarding physical examination, immunizations, drug screen, background check, CPR and Performance Standards for Admission and Progression is available in the [Associate in Science Degree in Nursing Application Booklet](#).

Specific deadline dates will be required for submission of these documents. Information for obtaining these tests/reports will be provided in a mandatory meeting—date to be specified in the provisional acceptance letter from the School of Nursing. Students who receive provisional or alternate acceptance status may give up their seat and be moved to the bottom of the alternate list if absent from mandatory meets and/or fail to complete and submit required documents on time.

These reports should not be submitted with initial application materials.

NON-ACCEPTANCE INTO PROGRAM

PERFORMANCE STANDARDS FOR ADMISSION AND PROGRESSION*

Nursing involves the provision of direct care for individuals and is characterized by the application of knowledge in the skillful performance of nursing functions. Therefore, in order to be considered for admission or be retained in the program after admission, all students must be able to demonstrate the following abilities without accommodations. Successful completion of nursing courses require students to attend a didactic lecture, laboratory, and inpatient clinical:

Issue	Standard	Examples of Necessary Activities (not all- inclusive)
Critical Thinking	Critical thinking ability sufficient for clinical judgment.	Identify cause-effect relationships in clinical situations; develop nursing care plans.
Interpersonal	Interpersonal abilities sufficient to interact with individuals, families and groups from a variety of social, emotional, cultural and intellectual backgrounds. Ability to cope with stress. High degree of flexibility.	Establish rapport with patients/clients and colleagues.
Communication	Communication abilities sufficient for interaction with others in verbal and written form. Ability to cope with anger/fear/hostility of others in a calm manner.	Explain treatment procedures, initiate health teaching, document and interpret nursing actions and patient/client responses.
Mobility	Physical abilities sufficient to move from room to room and to maneuver in small spaces. High degree of flexibility.	Move around in patient rooms, work spaces and treatment areas; administer cardiopulmonary procedures.
Motor Skills	Gross and fine motor abilities sufficient to provide safe and effective nursing care.	Calibrate and use equipment; position patients/clients.
Hearing	Auditory ability sufficient to monitor and assess health needs.	Hear monitor alarms, emergency signals, auscultatory sounds, cries for help.
Visual	Visual ability sufficient for observation and assessment necessary in nursing care.	Observe patient/client responses. Accurately prepare and administer medication.
Tactile	Tactile ability sufficient for physical assessment.	Perform palpation, functions of physical examination and/or those related to therapeutic intervention, e.g. sense temperature change, assess peripheral pulses, insert a catheter.
Strength/Stamina	Sufficient stamina to provide patient care in the clinical setting and related responsibilities for extended periods of time (8-12 hrs). Ability to lift/manipulate/ move at least 50 lbs. Transfer clients to chairs/stretchers, tables/move and manipulate equipment.	Adapt to shift work. Lift without restrictions, from standing position. Students with weight restrictions cannot be accepted into clinical courses.
Occupational Exposure	Ability to protect self and others by implementing appropriate precautions due to possible exposure to communicable disease and/or body fluids, toxic substances.	May be required to perform procedures and/or come in contact with patients/clients with communicable diseases. Provide total care using standard precautions.
Personal Behavior	Emotional health sufficient for full utilization of intellectual abilities, effective functioning during stressful situations, ability to adhere to professional boundaries, Code of Ethics for Nursing American Nurses Association.	Demonstrate honesty, integrity and accountability, perform multiple responsibilities concurrently; handle strong emotion. Adapt to changing patient/client care situations, respect patient/client rights and avoid criminal behaviors such as chemical dependency and abuse. Maintain professional boundaries.

I understand that I may not be permitted to enroll and complete any nursing course with a clinical component until I have all of my records on file in the nursing department (health, CPR, immunizations,
